## SOLID WASTE SERVICES CANCELLATION REQUEST

I, the undersigned, attest that I am the owner of the properties listed below, and hereby request that the City cease providing solid waste services at these locations:

By my signature below I also attest that I have entered into a contract for the period from July 1 to June 30 with a company in the business of providing solid waste collection and disposal to serve the location(s) listed above, and that I have reviewed and understand the information included on this form.

### Requirements for Consideration:

1. The property owner must submit this signed document acknowledging that he/she has reviewed this policy and understands the process and requirements.
2. The property owner must also submit a copy of a contract for solid waste services at the addresses indicated above. The contract shall be:
  - For the period July 1 to June 30 (fiscal year).
  - Signed by the property owner and the private hauler.
  - With a company in the business of providing solid waste disposal.
3. The request for cancelling Solid Waste services and supporting documentation must be received by the Statesville Public Works Director by June 15, 2018.

### If the request is granted:

- The City will retrieve any City-issued garbage and recycling roll-out carts assigned to this location(s), and will no longer provide garbage and recycling collection. **Collection and disposal of yard waste, loose leaves, bulky items, white goods and all other solid waste services currently provided by the City will also cease.**

- The City of Statesville will notify the Iredell County Tax Office to have the annual City solid waste fee (\$120) removed from the property owner's annual tax bill for the subject location(s).
- The Public Works Department will verify with the private solid waste hauler on a quarterly basis that the service contract is still in place. If the contract is no longer in place, the City solid waste fee will be reinstated, the pro-rata portion of the annual fee will be charged to the property owner, and City solid waste services will resume at the affected address(es).

**Other Information:**

- The property owner will be required to adhere to all City regulations that relate to disposal of waste items and placement of containers and other items at the curb. Violations of these regulations will be referred to the Code Enforcement Officer.
- If, at any time, the property owner desires to receive city solid waste services again, the pro rata portion of the \$120 annual fee must be paid prior to City services resuming.
- This option will only be available at the start of each fiscal year (July 1). Requests received mid-year will not be implemented until the start of the following fiscal year.
